# Our History

Shure dates back to 1910 when Richard C. Richardson and a partner operated an architectural sheet metal workshop in St. Louis, MO. In 1920, Richard's son, Joseph A. Richardson, joined his father as a sheet metal craftsman. He later became a registered professional engineer and industry leader.

In the early 1930's, Joe joined Anheuser-Busch where he worked on the fabrication of metal ice cream cabinets and beer dispensing boxes. In 1938, Joe and a friend leased a Texaco service station. The business taught Joe how to best merchandise and sell tires, batteries, accessories and automotive service. The sideline business later formed the basis for the direction of Shure Manufacturing Corporation.

In December 1941, Joe joined with Samuel J. Shure in St. Louis to start a metal shop. As World War II began, the company focused on war related products such as airplane parts, fire extinguishers and stove cabinets. After the war, Joe relied on his automotive experience and was asked to assist another St. Louis company in filling a contract for General Motors. Samuel and Joe were given an order to manufacture high-quality, enamel finished workbenches, cabinets, merchandise displays and desks.

Eventually, Shure began to assist national accounts, such as Shell Oil, Texaco, Conoco, Firestone and Chrysler to supply retail sales and shops with productive and image related merchandising furniture fixtures and cabinetry. Shure supported and continues to support independent automotive and equipment distributors, as well as national account programs.

While Shure's focus on the automotive industry has not changed, the industry has changed dramatically. Through the years, Shure's product lines have developed and expanded into new markets, to include a full line of workbench systems, storage cabinets, tool storage cabinets, cart systems, tire service equipment and various shop equipment, as well as shelving and storage solutions.

## INTERNATIONAL CREDIT TERMS

International exports will require full payment in advance of shipment unless otherwise negotiated & agreed to by Shure.

## SHIPMENTS

All shipments are made F.O.B. Shure Manufacturing Corporation, 1901 West Main Street, Washington, MO 63090. Transportation charges will be prepaid & added to your invoice unless otherwise requested & agreed upon. A service charge of \$10.00 will be added for all prepaid shipments. At times it becomes necessary to back-order items to give you the best service. We do not assume any responsibility for extra transportation charges. All shipments include the necessary hardware to completely assemble each unit.

## CANCELLATIONS

Orders canceled after being entered & are in the process of being manufactured are subject to a cancellation charge. Engineered to order "custom requests" are non-cancelable.

## TITLE AND RISK OF LOSS

Title & risk of loss passes to Buyer upon delivery of the goods at the delivery point. As collateral security for the payment of the purchase price of the goods, buyer hereby grants to seller a lien on & security interest in & to all of the right, title & interest of buyer in, to & under the goods, wherever located & whether now existing or hereafter arising or acquired from time to time, & in all accessions thereto & replacements or modifications thereof, as well as all proceeds (including insurance proceeds) of the foregoing. The security interest granted under this provision constitutes a purchase money security interest under the Missouri Uniform Commercial Code.

## RETURN SHIPMENTS

Return shipments will not be accepted without written authorization from the company. Returned merchandise is subject to a minimum 15% handling & restocking charge, plus necessary repair and / or refinishing costs. No cash refunds. Reimbursements will be given as credit to customer's account. All return shipments must be shipped freight prepaid.

## DAMAGED SHIPMENTS

All Shure products are carefully & securely packed in accordance with carrier requirements. The receipt of our merchandise by the transportation company ends Shure's responsibility. However, for your protection, before accepting any shipment, examine it carefully. If there is evidence of damage or shortage, insist that the delivering carrier make suitable notation to that effect on the freight bill before signing. If, after receipt of shipment, concealed damage is discovered, notify the carrier immediately.

Caution: When you give the delivering carrier a clear receipt for a shipment in which there is damage or shortage, the carrier is relieved of further responsibility.

Any claim for damage, shortage, loss or delay must be filed by you with the delivering carrier within ten days of receipt of shipment. Your recourse is with the delivering carrier.

## ORDER DELAYS

Any order that production has begun may be subject to warehouse storage fees.

## CUSTOMER INITIATED ORDER REVISIONS

Customer initiated order revisions will be reviewed on a case-by-case basis to determine if additional charges or manufacturing lead time extensions are required. ## CUSTOMER INITIATED SHIPPING DELAYS

Customer initiated shipping delays within 14 days of the originally established shipping date will result in an invoice issued for payment. The invoice will be issued on the originally established shipping date with actual freight charges to be billed after the order is shipped. Additionally, storage charges will apply for all orders delayed greater than 14 days from the originally established shipping date.

## REQUEST FOR A RETURN OF GOODS

Shure will not accept any returned shipments without pre-authorization by Shure. Requests to return products will be reviewed & determined on a case-by-case basis. All Shure orders are painted to customer's purchase order specifications & generally "configured" to the customer's facility requirements. Any authorized returned products are subject to a restocking & handling charge, plus any necessary repair and / or refurbishing costs. There are absolutely no cash refunds. Any authorized refunds will be issued as a credit. Any authorized return shipments must be shipped directly to Shure's Washington, Missouri location freight prepaid.

## DELIVERY INTERVAL

Shure Manufacturing Corporation is committed to providing high quality products & appreciates receiving purchase orders with sufficient production lead-times. All Shure products are considered "Custom Manufactured" as all products are painted to order. Manufacturing & production lead times & deliver intervals vary by product type, quantity ordered & current production schedule. Requests for expedited delivery intervals will be evaluated on a case-by-case basis & are dependent upon product type, quantity ordered & current production schedule. Note: Product design & specifications of all products in this catalog or quote are subject to change without notice.

# PRODUCT WARRANTY

Shure Manufacturing Corporation warrants to the purchaser of this product that should it fail, due to defective manufacturing workmanship and/or materials, within 13 months from the date of shipment (or within 12 months of the date of installation in the case of resold products) Shure will repair or replace, at Shure's discretion, any defective part or unit without charge for the replaced part or unit.

Shure will furnish a replacement part, or unit, warranted for the remainder of the original warranty period, FOB Washington, Missouri. This Warranty does not include labor or any other costs incurred for routine servicing, maintenance servicing, replacing, removing, shipping or handling of either defective or replacement parts, or the complete unit, except as stated above. This Warranty also excludes all costs associated with removal, dismantling, shipping and installation of any replacement parts. Purchaser is responsible for any removal, freight, and installation or handling charges of the installing dealer, distributor or contractor. These costs may be covered by a separate warranty provided by the installing/selling dealer, distributor or contractor.

For resold products, in establishing the date of installation used in determination of the starting date for the 12 month term of this Warranty, proof of the original installation date must be presented (Purchaser must present original records that establish the installation date of the unit), otherwise the effective period of the Warranty will be based upon the date of shipment to the installing/selling dealer, distributor or contractor.

This Limited Warranty applies only if the product is installed in compliance with manufacturer instructions, local installation and building codes, maintained according to manufacturer instructions and operated under normal working conditions and good trade practices. This Warranty does not cover damage caused by accident, negligence or abuse; operating the product in an negligent manner; modification, alteration, repair or service of the product by anyone other than an agent of the installing/selling dealer, distributor or contractor; failure to provide proper maintenance and service to the product according to the Manufacturer's instructions; installation of the product in a manner contrary to the instructions of the Manufacturer; acts of God.

The installing/selling dealer, distributor or contractor may then contact, on Purchaser's behalf, or have Purchaser contact direct, Shure to discuss the failure circumstances, provide Limited Warranty documentation and possible remedial action.
2. If replacement is required, Purchaser must furnish billing information for the replacement parts before shipment from Shure. Upon return of the replaced unit, in the replacement shipping material to Shure Manufacturing Corporation, 1901 West Main Street, Washington, MO 63090, and at Shure's discretion after inspection of the returned parts or unit, Purchaser's Warranty account will be credited for the amount of the replacement part(s) or unit. Shure reserves the right to reject any Warranty damage claims resulting from accident, negligence or abuse; operating the product in an negligent manner; modification, alteration, repair or service of the product by anyone other than an agent of the installing/selling dealer, distributor or contractor; failure to provide proper maintenance and service to the product according to the Manufacturer's instructions; installation of the product in a manner contrary to the instructions of the Manufacturer; acts of God.
3. If the replaced part(s) or unit is (are) not received within 30 days of replacement part shipping, or at Shure's discretion, all Limited Warranty failure conditions are not met, Purchaser will be billed for the full amount of the replacement part(s) or unit. Any order that production has begun may be subject to warehouse storage fees.
